Dr. Kirol called the meeting to order and stated notice of this meeting had been provided to all persons, organizations and news media, which have requested notification, as required by Section 30-4-80(e) of the South Carolina Code of Laws.

Item 1: Docket No. 16-RFR-21, Peter J. Kuhns – Issuance of State Critical Area Permit OCRM-15-211-B to construct a private recreational joint use dock. Requestors – Michael and Lisa LaPlant (Attachment 1-1)

Mr. Hewitt opened discussion on this matter and issues raised in the RFR filed by Mr. and Mrs. LaPlant and the specifically the issue of Lot 29 being classified as a water front lot.

Mr. Hewitt sent the RFR Committee members a map via email showing the property in question. (Attachment 1-2)

Mr. Hewitt moved, seconded by Mr. Batts to conduct a Final Review Conference to address the issue of Lot 29 meeting the definition of a waterfront lot. During further discussion, **Mr. Batts moved, seconded by Mr. Hewitt, to go into Executive Session for the purpose of obtaining legal advice. The RFR Committee voted and Motion carried.**


Dr. Kirol announced the RFR Committee was back in public session and while in Executive Session, no actions were taken.
