Each program has a sub-level certification for measurement. Below is a brief description:

- National Radon Proficiency Program (NRPP): [www.aarst-nrpp.com/wp/](http://www.aarst-nrpp.com/wp/) or 1-800-269-4174
  - Certified Residential Measurement (RT): Places and retrieves measurement devices for analysis by a certified laboratory.
  - Standard & Analytical (SA): Places and retrieves measurement devices for analysis by a certified laboratory, and/or analyzes specific measurement devices on behalf of a client (but not for other measurement professionals).
  - Advanced Certification in Multifamily Measurement (MFM)

  - Radon Measurement Technician (RMT): Radon Measurement Technicians are people who have been trained and certified in the fundamentals of radon testing. RMTs are qualified to place and retrieve measurement devices for the purpose of collecting radon data.
  - Radon Measurement Specialist (RMS): requires demonstration of knowledge which goes significantly beyond that required of a technician. RMS's are qualified to analyze -- rather than simply report -- radon measurements in a manner that is consistent with current knowledge.
