## S.C. DHEC NEWBORN SCREENING NEWSLETTER

Welcome to the new quarterly Newborn Screening newsletter. These publications will include helpful tips for specimen collection, submission, follow-up contact information for DHEC NBS staff, and an educational section on specific disorders found on the newborn screening panel. We hope you find these helpful as we constantly aim to improve screening of South Carolina newborns.

### OUR BEST FOOT FORWARD

- First Time, Every Time regional hospital training in collaboration with the SCHA and DHEC lab was a success! There were six training workshops with good turnout from all S.C. hospitals. Participants were instructed how to collect a good blood spot correctly and important follow up procedures. Our hope is to have 0 percent unsatisfactory specimens, which will decrease the need for repeat specimens.
- The NBS lab is in the process of implementation of a new laboratory information management system, Specimen Gate. In this new system, healthcare providers will have electronic access to their patient's results. The expected launch date is early 2017.

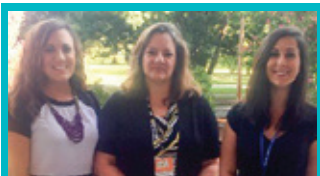
