#### ITEM BY ITEM INSTRUCTIONS FOR COMPLETING THIS FORM:

#### SECTION 1.

Enter the date of the plans and specifications in the first space, the name of the S.C. Registered Architect/Engineer who prepared the plans and specifications in the second space, the number of the S.C. Registered Architect/Engineer who prepared the plans and specifications in the third space and the appropriate application fee in the fourth space. Fees are based on the following computation schedule:

### Type A, B, C, D, F, or G pools

Base fee + size fee per the following:

- (1) Base fee \$400.00
- (2) Size fee \$0.50 per square foot of pool surface area

Type E flumes, water courses, or pools

Fee - \$1000 per flume or water course

Fee - Type E <u>pools</u> are charged according to the schedule to the left

Enter the address, phone number, and e-mail address of the S.C. Registered Architect/Engineer in the next three (3) spaces.

SECTION 2. (Pool Details)

Enter the full name of the facility, the physical location of the facility, to include the street or road, city, state, and zip code. Also enter the county, the phone number at the facility and the project cost as defined by South Carolina Department of Labor, Licensing, and Regulation, General and Mechanical Contracting Act, Chapter 11, Title 40..

SECTION 3. (Construction Responsibilities)

Enter the type of pool (A,B,C,D,E,F,or G per regulations) to be constructed or altered in the appropriate space. Enter whether or not the pool will be used year round and whether or not the pool will be located indoors or outdoors. Enter the perimeter in linear feet, the area in square feet, the volume in gallons, the minimum flow rate in gallons per minute, the design flow rate in gallons per minute and the total deck area in square feet of the pool to be constructed or altered in the appropriate spaces. Enter the number of people, per regulations, that the pool to be constructed or altered can safely accommodate and the number of people, per regulations, that the deck surrounding the pool to be constructed or altered can safely accommodate in the appropriate spaces.

Select the appropriate responsible party(Owner - O, Builder - B, or Not Applicable - N) Review each item in the left-hand column. Determine whether the builder or the owner will be responsible for the item or if the item is not applicable to this facility.

Section 4. (Pool Builder)

Enter the company name, contact person, e-mail address, telephone number including area code, and complete mailing address, including zip code, of the pool builder who will be constructing or altering the pool in the appropriate spaces. Enter the S. C. Swimming Pool Contractor's license number (required for projects of \$5000 or more).

Section 5. (Owner)

Type the name of the owner, enter the owner's telephone number including area code, enter the owner's e-mail address, and the owner's complete mailing address including zip code, in the appropriate spaces. The owner, or designated representative, must sign the application (the signature must be original) and enter the date the application was signed in the appropriate spaces.
