Spartanburg, Laurens, Newberry, and Greenwood Counties

Dear Mr. McKenzie:

The South Carolina Department of Health and Environmental Control (Department) has reviewed the above referenced Hydrostatic Test Water Notice of Intent (NOI) for hydrostatic testing of a new pipeline which includes approximately 55 miles of 12-inch diameter steel pipe. The installation will originate at the Dominion Carolina Gas Transmission, LLC (Dominion) existing Moore Purchase facility near the intersection of Pearson Town Road and Moore Duncan Highway near Moore, SC, and terminate at the Chappell's Tie-in with Dominion's Line N located near Chappells, SC. Hydrostatic testing using filtered raw river water or municipal drinking water will result in multiple discharges (as detailed in the cover letter for the NOI) with a total discharge volume of approximately 1,895,258 gallons. Discharges will be into a geotextile-lined dewatering structure located in an upland area within Dominion's right-of-way. Silt fence, hay bales, check dams, and other measures will be used to prevent erosion. The Department approves this NOI as follows:

The hydrostatic test water must be managed as outlined in the above-referenced NOI and in accordance with the requirements of the NPDES General Permit for Hydrostatic Discharges, SCG670000. Please take special note of the following:

You must comply with the requirements in Part III.F. of the general permit regarding your responsibilities for public notice of hydrostatic discharges of 15,000 gallons or greater.

You must comply with the requirements in Part IV of the general permit regarding your responsibilities for monitoring and reporting results of the hydrostatic test water discharge.

Part IV.A requires one sample per discharge to be taken when the discharge volume from a pipeline is less than 50,000 gallons, and two samples when the discharge volume is 50,000 gallons or greater. The sampling for these discharges is as follows:

One Sample (<50,000 Gallons): Taken when 5% of the test water has been discharged;

Two Samples (>50,000 Gallons): First shall be taken when 5% of the test water has been discharged, and the second when 95% has been discharged.

The individual who signed the Notice of Intent (or a duly authorized representative) must also sign reports required by this permit and other information requested by the Department. Part V.I (Signatory Requirements) of the general permit defines who the Department considers to be a duly authorized representative.
