**AMENDMENT TO VOLUNTARY CLEANUP CONTRACT
02-5295-RP**

**IN THE MATTER OF
SCE&G COLUMBIA FLEET MAINTENANCE SITE,
RICHLAND COUNTY
AND
SOUTH CAROLINA ELECTRIC & GAS COMPANY**

WHEREAS, on August 19, 2002, South Carolina Electric & Gas Company ("SCE&G") and the South Carolina Department of Health and Environmental Control (the "Department") entered into Voluntary Cleanup Contract 02-5295-RP ("Contract"), with respect to the SCE&G Columbia Fleet Maintenance facility located at 1409 Huger Street, Columbia, SC (the "Site"). For the purpose of this Amendment, the description of the Site has been amended;

WHEREAS, the terms used in this Amendment shall have the meaning assigned to them in the Contract;

WHEREAS, the original Contract described the facility as including approximately 9.5 acres (the "Property") and was bounded generally by residential properties on the north along Hampton Street, commercial and industrial businesses on the east along Huger Street and south along Washington Street including offices, an abandoned former lumber company and a steel fabricating industry, and Hampton Street to the west;

WHEREAS, the Department and SCE&G now desire to make certain modifications to the Contract by adding a new parcel to the legal description of the Property;

WHEREAS, the Department and SCE&G agree that the following description is hereby incorporated into Voluntary Cleanup Contract 02-5295-RP, and said Contract is amended as below as if included completely therein. The Department and SCE&G agree as follows:

1. The term "Property" as defined in the Contract shall also include the following:

Williams Street Transmission Substation -- Deed Description

All that certain piece, parcel or tract of land containing 4 acres, more or less, situate, lying and being in the City of Columbia, County of Richland, State of South Carolina, Richland County tax map number R08912-01-01. Said parcel is bounded on the north by the Hampton Street right-of-way for a distance of 417.42 feet, more or less, on the east by the Williams Street right-of-way for a distance of 420.10 feet, more or less, on the south by the

Washington Street right-of-way for a distance of 417.42 feet, more or less, and on the west by the old Gist Street right-of-way for a distance of 421.10 feet, more or less.

This being a portion of the property conveyed to the Columbia Railway Gas and Electric Company by deed dated July 3, 1905 and recorded in the Richland County Register of Deeds in Book AG at Page 589. The Columbia Railway Gas and Electric Company is corporate predecessor to South Carolina Electric & Gas Company.

NOW, THEREFORE, IT IS AGREED that Voluntary Cleanup Contract 02-5295-RP is hereby amended to incorporate the aforementioned items; all other terms and conditions of Voluntary Cleanup Contract 02-5295-RP shall remain in effect, except as specified herein.
