The South Carolina Department of Health and Environmental Control (the Department) has reviewed the Second Semiannual 2019 Groundwater Monitoring Report for the Brenntag Southeast facility in Charleston, South Carolina. The following comments were generated during this review.

1. As discussed in the September 2, 2020 video conference between the Department and representatives of Brenntag, Burriss Environmental Services and William Bird & Co., prior AFVR events are believed to have had a beneficial effect on contamination in the areas of MW-12 and MW-14. The Department concurs with the implementation of the proposed 72-hour AFVR events as an interim measure during the development of a permanent remedy.
2. In correspondence dated April 15, 2020 the Department requested that Brenntag submit a work plan for investigation of Area 2 soil and groundwater of sufficient scope to enable an evaluation of cleanup alternatives. As discussed in our conference on September 2, the Department understands that Brenntag will submit a work plan for this investigation within two weeks.
