The review area is part of an overall project known as Buist Hanahan Mine. Based on a review of the information you submitted, the delineated boundaries depicted on the map titled "Figure 2: Aerial Photo/Waters Map" and received September 15, are a reasonable representation of the aquatic resources located onsite.


