

Small Group Discussion Notes

- Whether to expand list of covered devices vs. keeping focus on current covered devices:
 - Value, effectiveness, efficiency of materials;
 - What would justify expansion; and
 - What are the methods to expand the list.
- What is the conditioned of recycled material and what can be sorted?
- Need for a common understanding by others of covered devices and definition.
- Choose to participate vs. Requirements
 - Option to charge a fee for Counties



Small Group Discussion Notes

- Collaborative Approach for longer term
 - Revisiting financial responsibility
- Retailer concerns on advanced recycling fees
 - Variations considered but not in practice
- Clearinghouse option that can be chosen in IL
 - Offers protection to smaller municipalities

- Financial assurance issues
- Inspection provisions and/or authority in regulation.
- R2 recycler qualifications
- Accounting for flow of material statewide/ Level of Responsibility:
 - By product type, by manager, by area
 - What portion of wastestream covered by manufacturers/local govt.
