CON NOTES APRIL 2023

On April 26, 2023, the House Regulations and Procedures Committee met and decided it best for the agency to withdraw and resubmit Regulation 61-15, *Certification of Need for Health Facilities and Services, Document #5136*. This action was based on the House Medical, Military, Public and Municipal Affairs (3M) Committee’s decision to pass [S. 164](#) favorably with an amendment. This bill will now head to the House floor for debate. Healthcare Quality plans to resubmit the proposed regulation in January 2024 with amendments based on the outcome of S. 164.

Hello Nursing Home Administrators:

In preparation for Fiscal Year 2024, Nursing Home Administrators who currently hold a Medicaid Permit should be on the lookout for the Medicaid Patient Days Request Form. The forms for FY2024 will be sent out around mid-May. Upon receipt, the forms should be completed, indicating the specific number of Medicaid Patient Days that the nursing home wishes to provide during the time period of July 1, 2023 – June 30, 2024, and returned to the Department. The deadline for submittal of the completed request form is June 15, 2023.
