She said the group sent an email out to Target Zero to see if they can patrol specific areas more. The TASC Injury Prevention Sub- committee has a proclamation request out to the Governor regarding unstrained adults and unrestrained children to bring more awareness to the issue. The group is also speaking with the office of Rural Health to find out what rural needs might be for car seats and restraints.
