SynTerra requests approval to install 40 monitoring wells at the above referenced location in Greenville, SC. Thirty-one proposed wells are shown on Figure 1. Nine additional wells are included in this permit request in the event field observations warrant additional well installation. Should additional wells be desired the location and details will be provided to SCDHEC prior to installation. These wells will be installed in accordance with the Remedial Investigation Work Plan Addendum submitted to SCDHEC on July 3, 2019. A completed SCDHEC Form 3736 (Monitoring Well Application) is attached, along with a site map showing the proposed monitoring well locations and typical monitoring well construction diagrams.

The monitoring wells will be installed by a well driller certified in South Carolina using the rotary sonic method. In accordance with South Carolina R. 61-71 Well Standards, Water Well Record Form 1903 will be submitted to SCDHEC for each well within thirty (30) days of completion.
