



## **Radon Mitigation Professionals**

Below are some questions that may help in selecting a radon mitigation contractor.

1. Is the contractor's certification current and in good standing?

There are two national radon certification programs, listed below. Please refer to their websites for the most up to date information and for certified professionals in nearby states that service South Carolina. *Please note:* the individual is certified, not the company. Some professionals have earned advanced certificates through additional coursework. If an individual has an advanced certificate, it is noted on the list on the other side of this page.

2. Is s/he willing to perform an on-site evaluation of the home before giving you a bid?

An on-site assessment of the home should be performed as part of the development of the bid for radon mitigation system installation.

3. Is there a system warranty? Review post-system installation service expected. Questions include, but are not limited to:

- Is system performance guaranteed to achieve results less than 4.0 picocuries per liter (pCi/L)?
- Who is performing the post-mitigation test and how will I get my results?
- What warranty on the system and parts does the mitigation technician include?
- What happens if the system failed to reduce radon levels below EPA's action level of 4.0 pCi/L?

With any contractor, remember to check references, get competing bids, ask to see examples of previous work, and review the contract thoroughly.
